### **Remembering Our Sisters**



At the meeting, I met women educators of all ages. I was very impressed with how these women interacted and spoke of education to honor teachers and those in our profession. It was uplifting to hear women promote the spirit of education in their words and in their deeds. I had never encountered a group quite like this in all of my past years of teaching.

When I learned about the seven purposes and heard the words to the Delta Kappa Gamma Song, I knew this was a very special organization. I became a member of the Chi Chapter of DKG in 2006 when Janet Ressler (Joan Stemen's daughter) was president. At that time, meetings were held on Saturday mornings at Millersville University. Real candles, real flowers, red gowns, a pianist, and a flannel graph presentation of the Coat of Arms made initiation a memorable experience for me. After a year of attending meetings, I was asked to chair the grant-in-aid committee. Although I was not sure of what I was getting into, I found this committee to be exciting and fun. I enjoyed working with Chi sisters to choose a recipient from 20 to 25 applicants for our small grant. My adventures with Chi, DKG, and beyond had begun.

As a wife, mother, graduate student and principal 24/7, my life was very full, busy and sometimes chaotic. Chi Chapter was very structured with expectations and procedures which were a welcome blessing to my life. Even as I began to understand bienniums, necrology, world fellowship, nominations, differences between scholarships and grant-in-aid, I came to know many wonderful ladies.

My first experience of DKG Beyond Chi occurred when I decided to attend a state convention. Music has always been a love of mine, so I signed up to sing in the chorus. Practices were at the convention but due to work, I arrived too late for the first one. However, I discovered Gisele and Carol Heintzleman also like to sing with DKG state chorus. It felt good to know someone and again meet new ladies passionate about education.

My experience at state convention turned out to be wonderful. I have enjoyed attending almost every year since then to find restoration and refreshment. From the Album of Distinction on the first evening, to the celebration of life and breakfast on the last morning, the state convention honors women in education. Sometimes it has been difficult to get away from my work and home, but the time at convention has always been worthwhile to me. The workshops, speakers, and fellowship with women educators has given me many special memories. Every convention I meet someone new, learn something new and leave refreshed and renewed. State Convention is an easy way to see DKG Beyond Chi–try it.

After serving as the chair of grant-in-aid for several years, I went on to accept positions in membership, programs and became a president of Chi Chapter. I worked with nominations, necrology, and book club. Each role has provided opportunities to build

relationships with dear sisters. I have found also found opportunities to attend an International Convention in New York City and Northeast Regional Conventions in Portland, Maine and Hershey, PA. I was able to sing in the chorus at these conventions and meet women from around the world. I recall sitting with a group from Japan at International never realizing I would be traveling there in several years with a group of students from School District of Lancaster. Chi Chapter is well represented at the state and international level. I cannot begin to name all those who are involved but I know there are many. I will never forget the excitement and pride I felt at the nomination of Dr. Lyn as our international president. It is also an honor to be a Chi sister of current Alpha Alpha State President Eileen Little. At all levels of DKG Beyond Chi you will find a friendly face.

Also, Beyond Chi are scholarships and grants. In 2010, I applied for a state scholarship and received the Dr. Laura Braun award in the amount of \$3,500. Then I applied for an International Scholarship. I receive the award letter in the mail March 2011. The award was the Dr. M. Margaret Stroh Scholarship. Due to my dissertation being completed at this point, I was unable to accept the \$6000 which would have been awarded to me. My message to you is, don't wait too long to start applying for scholarships. If you are working on a graduate degree, look into the scholarships <u>now</u>. Dr. Stroh was a founder of DKG Alpha Alpha State in 1940. She served as National President from 1942 to 1944 and National Executive Secretary from 1945 to 1956. Dr. Stroh is known for her speech entitled "White Hyacinths". As the daughter of a florist, I connected with the words of this great woman. She stated, "Leadership is waiting in your community. Prestige is there for those who in humility of spirit and understanding of the realities attain it because they have fixed their eyes upon the things that matter. The finger of Destiny points to this organization. White hyacinths are ready to bloom and are yours for the asking."

Spring is coming! Beautiful green sprouts will shoot up from the cold dark earth and develop beautiful, fragrant blooms of white. As you explore DKG Beyond Chi, you do not know what beauty and wonderment may unfold. It begins with the first step. See you at state convention ...

#### **Rationale for change:**

By recommending this change, Chi Chapter will provide a digital option for recommendations for membership.

#### 2.) Article III. Membership, Letter E, Section 3.

E. Orientation and Induction of Members-elect

3. An induction will be held within a year of a candidate being voted into membership. The Induction Chairman and committee will be in charge of the induction ceremony.
